Policy Owner: Financial Advice New Zealand Incorporated as owner of the FANZ Life Plan (the Plan) established for the benefit of the eligible employees of Financial Advice New Zealand Incorporated (the Employer).

Policy Replacement: This Corporate Solutions Life Insurance Policy issued to the above named Policy Owner by AIA New

Zealand Limited is comprised of the attached policy wording reference AIAGR-014-04 11/20 and the following Schedules and replaces policy 6029178 issued on 29 November 2018 by Sovereign

Assurance Company Limited in its entirety.

Policy Commencement Date: 01 July 2021

Renewal Date: 01 July 2022 and annually thereafter

Benefits: In respect of members insured for Life

When payable: In the event of the death of an Insured Member or an Insured Member

being diagnosed with a Terminal Illness while insured hereunder.

Amount payable: The Amount Insured applicable to the Insured Member for the applicable

Plan Year, subject to the maximum benefit amount of NZD10,000,000.

In respect of Members insured for Total and Permanent Disablement Benefits (if applicable)

When payable: In the event of Total and Permanent Disablement (as defined) of an Insured

Member while insured hereunder.

Amount payable: The Amount Insured applicable to the Insured Member for the applicable

Plan Year, subject to the maximum benefit amount of NZD3,000,000.

In respect of Members insured for Dismemberment and Major Burns Benefits $\,$

When payable: In the event of a dismemberment or major burn (as defined) of an Insured

Member while insured hereunder.

Amount payable: The amount specified in General Condition 27.

Total and Permanent Disablement: Applicable -

In respect of Members under age sixty-five (65): Own Occupation.

In respect of Members sixty-five (65) years of age and over: Activities of Daily Living.

Life Benefit Formula: For Insured Members aged between seventeen (17) to sixty-nine (69), the amount payable on the

death or terminal illness of an Insured Member shall be equal to the amount of insurance that the

member has applied and been accepted for, subject to a maximum of NZD10,000,000.

For Insured Members aged between seventy (70) to seventy-five (75), the amount payable on the

death or terminal illness of an Insured Member will be NZD50,000.

Total and Permanent Disablement Benefit: If applicable to an Insured Member, the amount payable on the total and permanent disablement

of an Insured Member shall be equal to the amount of insurance that the Insured Member has

applied and been accepted for subject to a maximum of NZD3,000,000.

Maximum Entry Age under the AAL: Age Sixty-Four (64)

Cessation Age: Life Benefit: Age Seventy-Five (75)

Total and Permanent Disablement Benefit: Age Seventy (70)

Automatic Acceptance Limit (AAL): NZD600,000, members aged 65 and older are not eligible for the automatic acceptance limit.

Eligibility for Automatic Cover: Eligible Members who meet all other eligibility criteria for automatic cover.

Eligibility Criteria:

a. Any Financial member of the Policy Owner (including those that hold a Membership Type/Class as Practitioner or Associate) who:

- prior to the Policy Commencement Date, had been a member of Financial Advice New Zealand Incorporated policy number 6029178 and was transferred to the policy on the Policy Commencement Date by the Policy Owner; or
- ii) applies to enter the Policy within 30 days of having been a financial member of the Policy Owner for three months (subject to (b) below).

b. Financial members of the Policy Owner who were members or previous members of Financial Advice New Zealand Incorporated, but who were not Insured Members (for whatever reason) of policy number 6029178 on 30 June 2021, are not eligible to enter the Policy under the Automatic Acceptance Limit and will require full underwriting to enter the Policy.

In the case of the death and terminal illness benefits, the date on which the member attains age 75.

In the case of the total and permanent disablement benefit, the date on which the member attains age 70

Life Benefit: To age Seventy-Five (75)

Total and Permanent Disablement Benefit: To age Seventy (70)

In **Definitions**, section **22. Continuation Option** is deleted in its entirety and replaced with the following:

"22. Continuation Option

If an Insured Member, prior to the attainment of the Cessation Age, ceases to be an Insured Member, other than as a result of death or the Policy terminating and provided that the Insured Member is not in receipt of or entitled to receive benefits under this Policy, that Insured Member shall be entitled to apply for and have issued, a Life Policy that the Company from time to time considers appropriate, without being required to produce any Evidence of Insurability subject to the following conditions:

- a) the Amount Insured under the individual policy will not exceed the amount of benefits payable in respect of the Insured Member under this Policy; and
- the individual policy will be subject to the standard policy conditions and provisions for similar policies issued to the public, including but not limited to residency status, location, occupational and minimum premium requirements; and
- the premium payable will be calculated at the rate charged by the Company on similar individual policies, taking into account the Insured Member's age, occupation, income, sex, and smoking status; and
- the policy will be subject to any extra premium or exclusion clause(s) imposed in respect of the Insured Member under this Policy; and

e) there are no outstanding or overdue premiums in respect of the Insured Member under this Policy.

The Company must receive written notice of application in the form prescribed by it within sixty (60) days of the date on which the Insured Member ceased to be employed by the Employer and subsequently insured under this Policy."

In **Definitions**, section **30 Bereavement Support** is added in its entirety:

"30. Bereavement Support

At the request of the Policy Owner, on receiving written notification of the death on an Insured Member, the Company has discretion to pay an early payment of the Life Cover Benefit of up to \$15,000 to the Policy Owner. Any amount paid will be treated as an early partial payment if the Life Cover Benefit under this Policy."
